Category	Requirement	Points (Indicative)
1. Basic Qualifications	MD/MS or equivalent (recognized by NMC, India) + RMP under State Medical Council/NMC	Mandatory (No points)
2. Clinical Experience	Minimum 3 years in clinical practice (Govt/ Private/Charitable) in India	10 – 20 pts
3. Frontline Service Contribution	Work in underserved, rural, tribal, or high-risk communities	10 – 30 pts
4. Patient Care Excellence	Proven excellence in emergency care, pandemic response, etc.	10 – 20 pts
5. Public Health Engagement	Participation in health awareness drives, immunization, or disease surveillance	5 – 15 pts
6. Community Medical Outreach	Leadership in free medical camps, outreach programs, or mobile clinics	5 – 15 pts
7. Ethics & Conduct	Clean disciplinary record; adherence to MCI Ethics Guidelines	Mandatory (No points)
8. Institutional Recommendations	Letter(s) of support from senior professionals/ institutions	5 - 10 pts
9. Prior Recognitions	Recognized by health departments, NGOs, or professional bodies	5 – 10 pts
10. National Participation	Active role in National Health Missions, disaster response, or government health programs	5 – 10 pts

5. Impact & Reach	Based on number of beneficiaries, target population served, consistency, and sustainability	20 points
